# Does your home still have damage from Hurricane Florence?

The South Carolina Disaster Recovery Office is introducing the Hurricane Florence Recovery Program for residents with remaining damage to:

- -REPAIR, RECONSTRUCT, or REPLACE single-family owner-occupied homes
- -BUYOUT of single-family owner-occupied homes (if located in a floodplain)
- -REPAIR single-family rental units for affordable housing

This new program is specifically designed to assist South Carolinian's who require assistance in the repair, replacement, reconstruction, or buyout of their homes damaged by Hurricane Florence.

The program expects to serve approximately 550 homeowners with the priority of assistance focused on the extremely low income, elderly, disabled, and families with children 17 years old or younger in the household.

#### WHO IS ELIGIBLE TO APPLY?

- Homeowners whose income falls between 0-120% of AMI
- · Priority of assistance:
  - Income Level (extremely low to low)
  - Disability (any family member)
  - Elderly (65 and over)
  - Children (17 years old and under)

All applicants must meet State and Federal guidelines and pass an environmental review. Applicants must also pass a review of previously received storm funds and show a need to participate in the program.
